#### **eVetting**

Since the switch to eVetting in November 2016.



the turnaround for vetting approval has significantly improved.

When comparing the same time period (Jan to Sept), there were 92 applications processed in 2016 vs 335 applications in 2017. Once applicants complete the email link that they receive from the Vetting Office a turnaround of 3-5 days can be expected.

We would like to thank everyone who has taken the time to complete their application through the new eVetting system.

# Ensure that your parish is displaying the correct poster

**Why?** New Safeguarding Posters have been distributed to all churches in the Diocese. It is important that the older versions of the posters are taken down as contact details have been updated.

For parishes that requested **Irish** and **Polish** versions of the posters these are now available. Please contact the Diocesan Office for copies.

#### **Designated Liaison Person**



In the Diocese there is one central number for all safeguarding concerns relating to children and vulnerable adults.

The Designated Liaison Person (DLP), Jim Sheehy is the main point of contact for all safequarding concerns.

Local Safeguarding Representatives numbers should be replaced with the number for the DLP in relation to reporting. For this reason, new posters have been distributed throughout the Diocese.

To support this important change, please ensure that the correct number is displayed in the following places: the church, the parish office, the sacristy and the parish newsletter.


